A History of Success

Backed by its solid equity resources and a strong corporate structure, Arkas offers an integrated service chain in its main business lines including maritime transportation, logistics, port and terminal operations, playing a pioneering role in Türkiye with the investments it has made in its own sector. Thanks to its dynamism and exceptional human resources, Arkas also shows that it has the power to make a positive impact on the sector as a whole.

Arkas views every individual with hands after the battle of whom it comes into contact, whether supplier or customer, as a valued member of its large family. Arkas family left the Arkas has been able to build up a island and settled in powerful services network, making the group a significant contributor to the national economy and to Türkiye's development.

Arkas was restructured at the turn of the millennium by the founding of Arkas Holding, which merges 66 companies operating in the transport, services and automotive sectors. The Arkas flag has now become a symbol of international transport in Türkiye.

A long journey...

Chekhov's maxim from long ago that "work will be our salvation" reminds us once again of the value of work at a time when we need dedicated, conscientious people more than ever. Arkas Holding's is one such story of success. It began nearly three centuries ago...

In 1711, a family member from the maternal side of the family, arrived in Türkiye from Marseilles and settled in Izmir to start a business. He began to export agricultural products such as grapes and figs to France. On the other hand, the Island of Corfu passed into British

Waterloo in 1815. After that, the paternal side of the Izmir. In1902, Gabriel Jean-Baptiste Arcas set up an import

company with two

French partners named Tissot and Champsaur. The partners left Türkiye during the First World War, leaving Gabriel J.B. Arcas to run the business on his own.

When Gabriel J.B. Arcas died in 1935, his son, Lucien Gabriel Arcas, who was then living in Marseilles, was summoned to Türkiye to replace him at the helm of company, named "Lucien Gabriel Arcas. Successor to Gabriel J.B. Arcas". Lucien Gabriel Arcas Lucien Gabriel Arcas continued this work until 1944. But

1943 marked an important turning point for the company. Fratelli Sperco, the owner of a powerful ship-owning company, asked Lucien Gabriel Arcas to become their company's

The number of ships increased and the agency became larger. Train transportation became a part of their repertoire, and the import business continued to flourish. This intensive work carried on until 1964, when Lucien Gabriel Arcas, inspired by his connection to passenger ships, decided to move into tourism. It was Lucien Gabriel Arcas who submitted a petition for a passenger port to be constructed at Kuşadası. Throughout these years, he conducted the company's operations personally, first from Cendeli Han and later from Kubilay Han, both in the Pasaport district of Izmir, the heart of the city's shipping activities.



Lucien Arkas

represented the family's third generation, took over the business in 1964. By this time the company's areas of operation included tourism and agency services for DSR Lines. In 1966, Lucien Arkas withdrew completely from the tourism and import business and concentrated all of his experience, knowledge and energy on maritime trade.

It was not easy going at first. In the I960's Izmir had no port to speak of, and goods were unloaded to the shore on a very narrow breakwater. The construction of Alsancak Port, begun in the I950's, was not completed until late in the following decade. For Arkas, then, it was not enough to simply make a decision, the agency had to be a leader and a forecaster, to think in many directions and select investments in light of how the sector would develop. Two important changes to affect

Seas of change

Arkas' recent history took place between the late 1970's and the early 1980's. The first was that containers began to be used in maritime trade. The second was that foreign trade gained visible momentum in Türkiye as of September, 1980. In 1972 Lucien Arkas accepted an

Pioneering the way

In 1972 Lucien Arkas accepted an offer from DSR Lines to represent the company in Istanbul and opened a new branch for the company. Container transportation, which first made its appearance in other parts of the world in 1956, finally reached Türkiye in 1978. Arkas shipped the first containers from Izmir to Northern Europe on the deck of a DSR Lines vessel named the "BURG".

Stimulated by the foreign trade boom that took Türkiye by storm in the 1980's, container transportation and foreign trade fed off one another to grow rapidly in tandem.

The one constant: change...

Being open to change is the key behind the development of Arkas as an organization. It is believed that change is necessary for improvement and that investment is the inevitable result of this. And keeping this in mind, initiatives are directed accordingly. Arkas noticed that land transport was a must to increase customer satisfaction in maritime transportation and thus created its land transport fleet in 1989 with 15 LORRIES, and this fleet now boasts 425 trucks. Arkas Logistics today serves in three main business lines including transportation and forwarding services, warehousing, and terminal services with 15 offices of its own in Türkiye and IO offices abroad.

In 1995 the company started container transportation services with two vessels for feeder purposes. Then in 1996 decided to provide management services and launched the first private container terminal in Istanbul. The company reaped the fruits of this investment in a very short time. Today Arkas achieved a merchant fleet consisting of 50 container vessels. I bulk carrier and 6 fuel tankers. This fleet now provides regular services to 68 ports in the Mediterranean, Black Sea and West Africa. It is a source of pride for the Turkish maritime sector that Arkas Line ranked in top 25 (aka the first league) as a Turkish company in a world-wide list announced by Alphaliner that includes shipowners operating fleets of container vessels.

Arkas, which has long been investing in railroads with its belief in the importance of railroad transportation in opening the doors for the Anatolia, established a land port called Railport in partnership with the German Duisport in Kocaeli. The land port that will help both railway and road transportations in an integrated manner in an important location which will be a hub for transports from Europe to China, is a prototype and a first in the sector. Arkas put its mark under many novelties in port management with its pioneering investments as it aims to contribute not only

to its own growth but also to the development of the sectors in which it operates.

Arkas established the container port Marport in 2001 as a very important initiative to support the development of foreign trade in Türkiye. By noticing the necessity of a suitable port infrastructure in automotive which is the number one export item in Türkiye, Arkas established Autoport in 2008 as Türkiye's first automotive specialized port at the intersection of storage areas of automotive manufacturers and distributor companies in Eastern and Southern Marmara due to the region being one of the most important logistics bases in automotive export. The company then established Adaport, a container terminal in Famagusta, Cyprus and also became a partner in the port of Terminal del Golfo in Italy.

These were followed by the establishment of Schenker Arkas, a joint company of Schenker and Arkas, which has the most extensive service network in Europe in road transportation. At this point, Arkas shaped its vision as a company with a focus on maritime, port management and logistics services... Both all and none. In fact all these steps are based on a plan, and each has a value in logistics. The business of agency of old days is now an industry rather than just an

enterprise. What Arkas is trying to achieve is to create its own autonomous field within this industry.

The journey continues...

Continuing its journey with firm steps for more than a century, Arkas today operates in many different sectors from automotive to insurance services, ship refueling, information systems and tourism in addition to its main business lines of maritime, port management and logistics services. Headquartered in Izmir. Türkiye, Arkas is an international holding that employs 8,300 people in its 61 offices and 66 companies in 24 countries in a geography stretching from North Africa to Western Europe and the Southern Mediterranean.

"To succeed, you first have to love your work and, of course, work hard..." says Lucien Arkas.

The success of Arkas is the result of all these intensive efforts and determination supported by technology and customer satisfaction. Arkas, which has become the symbol of international transportation, especially container transportation, in Türkiye, is moving forward with this philosophy.
